Each quarterly CSITC sample costs **US\$260.00**. A USDA Calibration Cotton Standards (CCS) can be ordered per each CSITC sample for **\$140.00 per 1 CCS**. Participants are advised to pay by check/draft to avoid costly wire transfer bank fees. If paying by wire transfer, please make sure to **add** bank fees to the total; the CSITC RT program **will not cover bank fees**.
